(b):- In case of running work, work order/supply order & up to date payment certificate of the Engineer- In – Charge must be produced as above. Partnership deed and other relevant papers (in case of Registered Farm/Company) should be produced at the time of submission.

2. Tender papers with all others documents will be available from the office of the undersigned on payment of cost of tender paper from 11.00 am to 16.00 pm on dated 15/03/2018 to 16/03/2018.

3. Tender paper complied in all respect be in sealed cover super scribing with the name of work, reference NIT No. etc on the top of envelope are to dropped in the tender box kept in the office of the Executive Officer, Kalna-II Panchyat Samity, Singerkone, Purba Bardhaman within & up to **1.30 P.M on dated 19/03/2018** & will be opened on the same date at 2.00 P.M. in presence of tenderers.

4. Time is the essence of contract .The successful contractor /Supplier must complete the work within the time specified for completion. No extension of time will be allowed except in special case. If any contractor/supplier fails to complete the work within the stipulated time, the work order issued in his favour will be cancelled without assigning any reason thereof. The undersigned may also proceed to get the balance work completed by any other means including through other contractor/supplier. The excess expenditure, if any due to such a step would be recoverable from the unpaid bills/security deposit of the tender. This is apart from any other penal measure that the undersigned may take, including black listing of the contractor/supplier and forfeited of carnets money.


5. Earnest money noted against the name of work @2.0% of the value of work will have to be deposited in the form of D.C.R. Nationalized Bank Draft in favour of **Executive Officer, Kalna-II Panchayat Samity**, Singerkone, Purba Bardhaman on or before the last date of submission. The earnest money will be converted into security money after acceptance of tender. Balance the security money will be released as per norms.
6. The rate should be quoted in percentage.
7. Copy of current year enlistment from the A.R.C.S. and copy of Resolution of last year will have to be submitted in case of labour/Engg. Co. - Operative societies. The tender forms are to be received by the Chairman or Secretary or any member of the Society having proper power of attorney. No tender form will be handed over to any outside. Credential of similar type of works will have to be produced in case of Engg. Co-Operative and Labour Co-Operative.  
\*Registered Unemployed Engineers' Co-operative Societies/Unemployed Labour Co.-Operative Societies are required to furnish valid Bye Law, Current Audit Report, and Certificate of Registration and Valid Clearance Certificate from A.R.C.S. for the year 2016/2017 professional tax deposit chalan for the Financial Year 2016-17, Pan Card and VAT Registration Certificate with up to date return along with other relevant supporting papers.
8. All works will have to be done according to schedule, specification and drawing approved by the authority and as per direction of the Engineer-in charge of the Block development office.
9. No consumable materials and working tools, plants and implement will be supplied to the agency for any work from the office of the undersigned. Agency will be responsible for processing all materials and tools and plants required for proper execution of work at his own cost including storing and guarding at site.
10. All rates shall be including of all charges, royalty, tool charges, carriage etc.


